Special Meeting

March 7, 2019

The Shelby City Schools, Board of Education met in special session on Thursday, March 7, 2019 at 5:15 p.m. at Shelby Senior High School, 1 Whippet Way, Shelby OH 44875

1. Meeting called to Order

1.1 The meeting was opened by Mr. Rose. Those present recited the pledge of allegiance to the flag.
